### Skilled workers and professionals: Who can apply?

Skilled workers and professionals are people who are selected as permanent residents based on their ability to become economically established in Canada.

Federal skilled worker applications received on or after February 27, 2008 are now assessed for eligibility according to a set of instructions issued by the Minister of Citizenship, Immigration and Multiculturalism.

Immigration application under this category will be reviewed in three steps.

### 1. According to Minister's instructions, your application is eligible for processing if:

You are a skilled worker who has at least one year of experience in one or more of the selected professions as below:

- Financial Managers
- Financial Auditors and Accountants
- Computer and Information Systems Managers
- Managers in Health Care
- Restaurant and Food Service Managers
- Construction Managers / Civil Engineers
- Mining Engineers
- Geological Engineers
- Petroleum Engineers
- Specialist Physicians and GPs
- University Professors
- College and Other Vocational Instructor



### 2. If your application is eligible for processing, you must also meet the following minimum requirements to qualify as a skilled worker:

- you have at least one year of continuous full-time paid work experience or the equivalent in part-time continuous employment, **AND**
- your work experience must be Skill Type 0 (managerial occupations) or Skill Level A (professional occupations)

## CANADIAN IMMIGRATION

Skilled workers and professionals are selected as permanent residents based on their education, work experience, knowledge of English and/or French, and other criteria that have been shown to help them become economically established in Canada.

The Federal Skilled Worker Program is for people coming to any part of Canada except Quebec. The rules for applying as a federal skilled worker or professional can change from time to time, so make sure you contact us before applying so as any updates can be incorporated.

3. If you meet these minimum requirements, your application will then be processed according to the six selection factors in the skilled worker points grid. The six selection factors are:

1. your education (up to 25 points)
2. your abilities in English and/or French (up to 24 points)
3. your work experience (up to 21 points)
4. your age (up to 10 points)
5. arranged employment in Canada (up to 10 points)
6. your adaptability (up to 10 points)

You must also show that you have enough money to support yourself and your dependants after you arrive in Canada.

Skilled workers and professionals: How much time it takes?

"We expect new federal skilled worker applicants, including those with arranged employment, to receive a decision within six to 12 months compared with up to six years under the old system," said Minister Kenney."

Advantages:

The Canadian Professional / Skilled Worker Visa allows migration to Canada as a Permanent Resident, without the need for an employer or sponsor, to seek employment and apply for jobs. Canada is keen to have Professionals / skilled workers for which the Canadian Immigration Points system is designed. This residence permission allows the right to apply for Citizenship after 3 years.

FAQs

What is the benefit of having Canadian permanent resident status?

According to the Canada's constitution, the holder of a Canadian permanent resident visa and his/her accompanying dependants are permitted to: a) permanently reside in Canada

and work legally. Canadian permanent residence b) Can also attend primary and secondary education in publicly administered schools just FREE of cost. Permanent residents can also qualify for provincially administered universal health care coverage.

Who is included in the application for permanent residence?

You and your spouse (over the age of 16) with any unmarried children under the age of 22. Children over the age of 22 may in prescribed circumstances, be included as accompanying family members.

What supporting documents must I submit?

a) Evidence of employment b) Evidence of Education, c) Your Age d) Passports detail including your family e) Police Character Certificate etc.

Will my application benefit if I have a close relative in Canada?

According to the Professional / Skill worker applicants will be awarded bonus points if the close relative is a Canadian citizen or permanent resident.

What are the applicable processing fees to process an application for permanent residence?

For applicants applying under the Professional / skilled worker program the application fee is currently set at \$550 CAD for each applicant, a fee of \$150 shall apply to each family member under the age of 22 years. As well, a Right of Permanent Residence Fee of \$980 CAD is levied, prior to visa issuance, for each person who is at least 22 years of age applying for permanent residence.
